- How do you learn about and respond to the capacity building needs of your grantees and your community, how could you change your funding to do so, and what are some opportunities to partner with other funders or government agencies/jurisdictions in support of the work of nonprofits?
- How has your organization learned about the history of inequity in philanthropy, and how have you changed your practices as a result?
- How do you or could you foster greater understanding about and connection with nonprofits within your organization? How do you or could you resource or fund sector collaborations and systems and structural change work?
- How do you support and fund nonprofits' evaluation, strategic planning, and capacity building work? How do you evaluate your own work, and how do you get feedback from nonprofits you support?

Government

- What are some opportunities for nonprofit business to inform and benefit from current and future workforce development initiatives?
- How do you learn about and respond to the capacity building needs of your community's nonprofits, and what are some opportunities to partner with other government agencies/jurisdictions or funders in support of the work of nonprofits?
- How can you learn about and implement strategies to prioritize diversity, equity, and inclusion in workforce development initiatives, in collaboration with nonprofits and funders?
